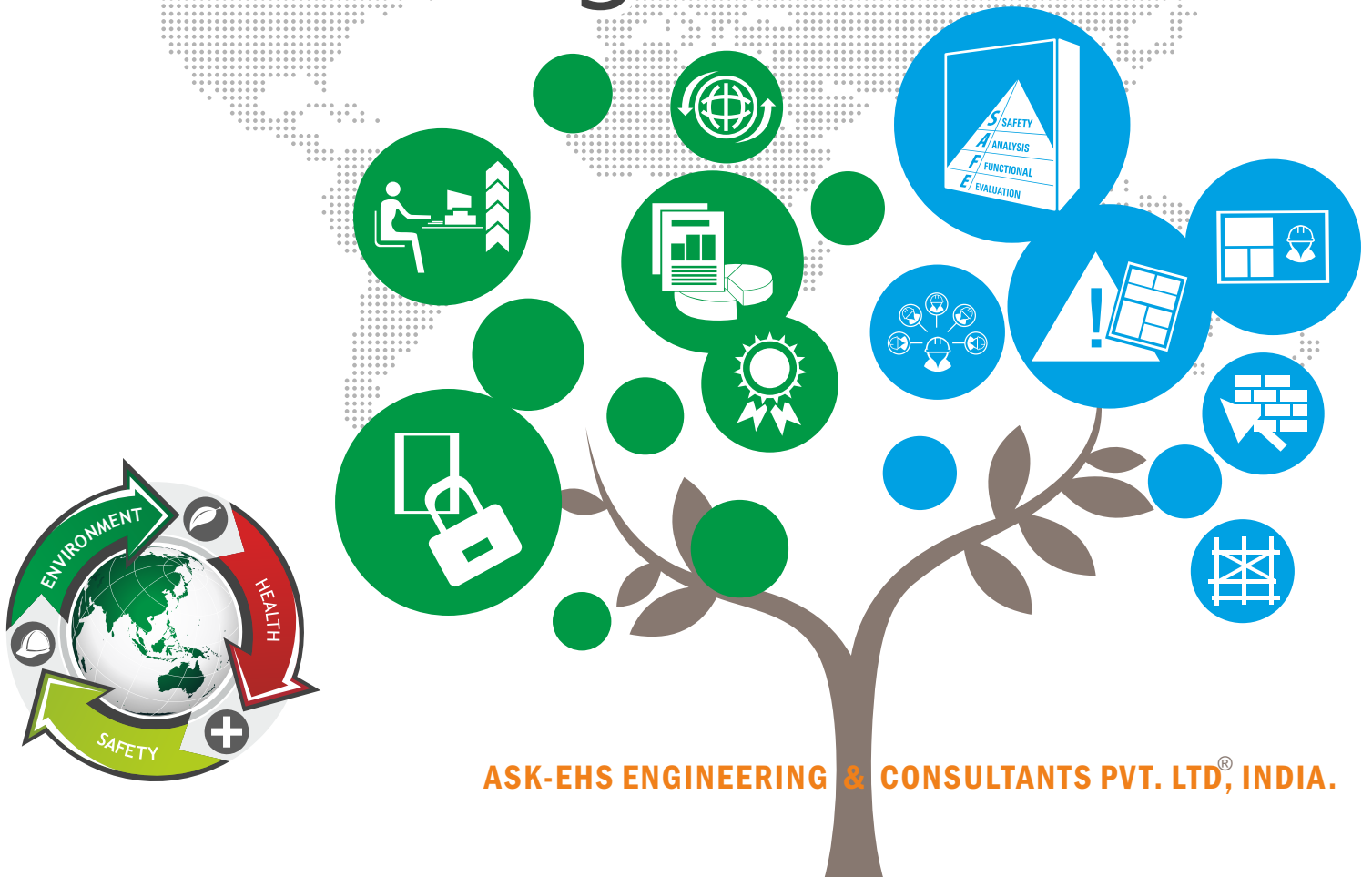

Case Study

Bajaj Auto Limited (India)

Bajaj Auto Limited has consistently been at the fore front of Automobile manufacturing in India. There are various big manufacturing plants in a single campus which is widely spreaded. A lot of mechanical, electrical and different engineering work happens as a routine and hence health and safety always remains the primary concern. They had permit to work process but it was purely a manual paper based process.

key challenges

- ▶ A single workflow of the permit system, that maintains the uniformity across the plant.
- ▶ Reduce the time to complete the permit process
- ▶ Include Various documents and related artifacts required for the job, which varies from job to job instead of single document format.

What we did

- ▶ An automated software system with the customized Permit to Work flow as per the need of Bajaj
- ▶ A web based solution, that can be accessed from any corner of the campus within the network infrastructure of Bajaj
- ▶ An automated process that will include all/any documents related to a particular job.

Results

- ▶ A uniform and well defined process of PTW
- ▶ An automated system, saving lot of time for employees walking around places to places for permits
- ▶ With anytime and anywhere approval access, resulted into saving total time that was spent waiting for approval in the absence of approver



Permit to Work Software

Permit to work has been very vital but not effective there. They had an existing paper based system running but was not proving to be full proof and effective.

key challenges

- ▶ The existing system was dated and used a paper based system that included many intricate sub-procedures within a single frame
- ▶ Implementation of JHA and Risk analysis aspects in an automated system
- ▶ A thorough understanding of isolation mechanism and hence implementation of the same which adheres to their system
- ▶ A thorough understanding of the Oil Refinery domain was a bit of a challenge considering the magnitude of the project and work carried out there

- ▶ Total automated process including Risk analysis components
- ▶ An interactive backend administration portal for configuration and settings

Case Study

Kiewit Corporation Limited (USA)

Kiewit Corporation is an employee-owned Fortune 500 contractor based in Omaha, Nebraska. Privately held, it is one of the largest contractors in the world having 50,000+ employees over the globe. The employee-owned company operates through a network of offices and projects in the United States, Canada and Australia.

key challenges

- ▶ Single plant/project has 600+ scaffolders at peak. It was completely managed manually.
- ▶ It became a challenge to the company to track, manage, follow, the activities of scaffoldings across the projects. A lot of manual time and effort was being spent consolidating the information from all across.
- ▶ Target number of users were approximate 2000 and estimated 200 concurrent users
- ▶ Being a foreign MNC, there was a bit of concern about the expertise of ASK-EHS in the domain of Scaffolding, HSE & IT.

Results

- ▶ A uniform and well defined process of Scaffolding
- ▶ Approval time reduced from 3 days to almost zero time due to the real time systems.
- ▶ Features such as notification and alerts for tasks and activities reaped benefits of anytime/anywhere. Resulting into saving lot of time.
- ▶ It used to take approximately 100 hours to prepare report, which now can be visible on a single click.
